Tuition is due the first day of the month for which it applies and will be considered late if received on the 10th or later. A \$35.00 late fee will be assessed on late payments. In the event a new student begins classes after the first full week of the month, tuition will be prorated for that month. The yearly tuition fees are adjusted into 9 equal installments for the school term 2011-2012.

A non-refundable enrollment fee of \$50.00 shall be returned to MSYC with this application. An annual **\$150.00 materials fee per** student is required for all children enrolling in the Montessori School for Young Children. **Half, \$75.00, is due with this application; the second half, \$75.00, is due January 2012.**

I understand I may withdraw my child when I give written notice to MSYC 30 days prior to withdrawal. I also understand that tuition is not subject to adjustment due to illness or absence.
